

Nevada Medicaid and Nevada Check Up



Nevada Medicaid

Provides health care coverage for many people including low income families with children whose family income is at or below 133% percent of poverty, Supplemental Security Income (SSI) recipients, certain Medicare beneficiaries, and recipients of adoption assistance, foster care and some children aging out of foster care.

The DHCFP also operates five Home or Community-Based Services waivers offered to certain persons throughout the state. The Division of Welfare and Supportive Services (DWSS) determines eligibility for the Medicaid program. Nevada Check Up

The Mission of the Nevada Check Up program is to provide low-cost, comprehensive health care coverage to low-income, uninsured children (birth through 18) who are not covered by private insurance or Medicaid, while (1) promoting health care coverage for children; (2) encouraging individual responsibility; and (3) working with public and private health care providers and community advocates for children.

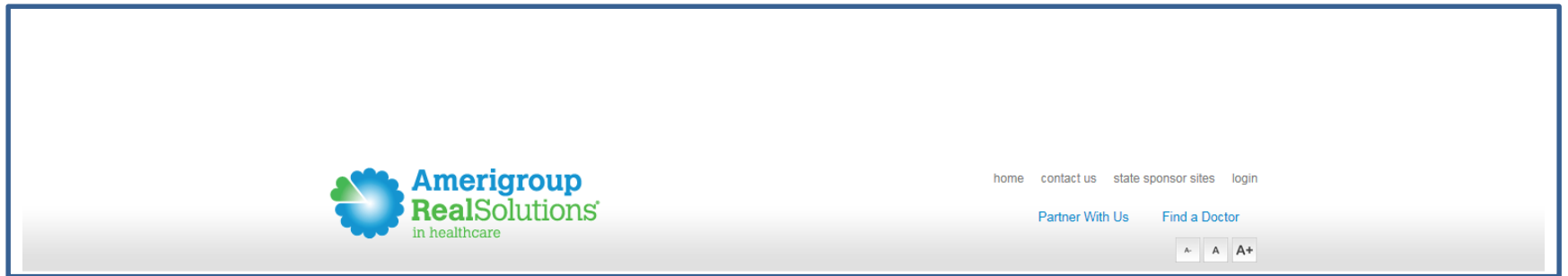

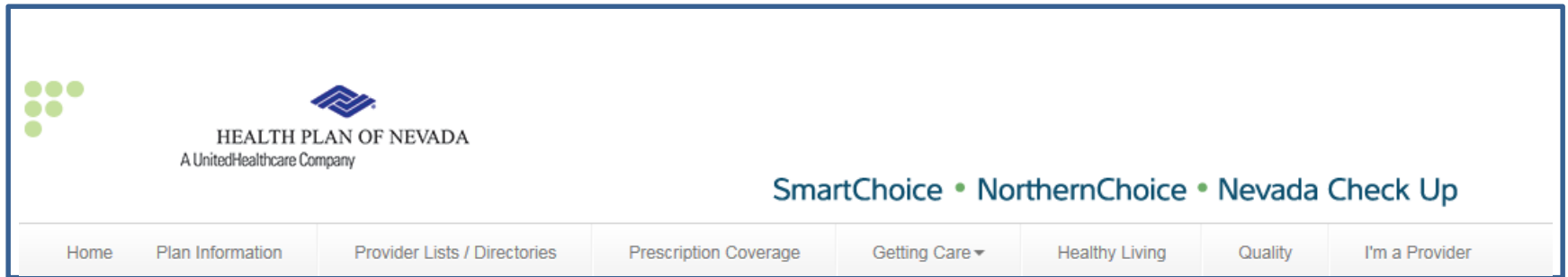
