

November 26, 2024 Nevada Medicaid Web Announcement 3489

Error Codes 5612 and 5619 Updated for Current Procedural Terminology (CPT) Codes 92510–97761

Effective on claims with dates of service on or after November 25, 2024, the following updates have been made to error codes 5612 (12 encounters allowed per calendar year – PA override) and 5619 (24 encounters allowed per calendar year – PA override):

Error codes 5612 and 5619 no longer apply to the following procedure codes:

- 92510 (Rehab for ear implant)
- 97124 (Massage therapy)
- 97533 (Sensory integration)
- 97033 (App modality 1+iontophoresis each 15)
- 97034 (App modality 1+ contrast bath each 15)
- 97036 (App modality 1+ Hubbard tank each 15)
- 97113 (Aquatic therapy/exercises)
- 97530 (Therapeutic activities)
- 97542 (Wheelchair management training)
- 97760 (Orthotic management 1st enc)
- 97761 (Prosthetic training 1st enc)

Error codes 5612 and 5619 no longer apply to the following provider types (PT) when billing specific procedure codes:

- 12 (Hospital, Outpatient)
- 17 (Special Clinics)
- 34 (Therapy)

Error codes 5612 and 5619 have been updated **to apply** to the following PTs when billing specific procedure codes:

- 20 (Physician M.D., Osteopath, D.O.)
- 21 (Podiatrist)
- 24 (Advanced Practice Registered Nurses)
- 36 (Chiropractor)
- 74 (Nurse Midwife)
- 76 (Audiologist)
- 77 (Physician's Assistant)

Additionally, effective on claims with dates of service on or after November 25, 2024, the following procedure codes **no longer require** prior authorization (PA) when billed by PT 34:

- 92601 Cochlear implant f/up exam under 7 years old
- 92602 Reprogram cochlear implant under 7 years old
- 92603 Cochlear implant f/up exam over 7 years old
- 92604 Reprogram cochlear implant over 7 years old

No claims will be reprocessed automatically as these are go-forward changes.
